SECTION 4: First aid measures

4.1. Description of first aid measures

Treat symptomatically.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Adapt extinguishing agent to suit the environment. Water spray. Foam. Carbon dioxide. Dry extinguishing powder.
